2. Postponement cannot result in annulment except by mutual consent.
3. The constitution, by-laws and regulations of the Ohio High School Athletic Association and the Handbook for Officials are a part of this contract.
4. The suspension of membership in the Ohio High School Athletic Association by either of the parties to this contract shall render this contract null and void.
5. This contract shall be returned no later than **August 31, 2022** or it will become null and void.
