Barring unforeseen difficulties, roster and seed information will be posted by 9:00 PM on the 13th!

### Friday, January 15, 2010

7:00 PM Check-in at Cleveland State University Woodling Gym and make corrections to roster and seeds.

7:30 PM Seeding Meeting (followed by dinner).

A. Brackets will be drawn and distributed after dinner.

B. Brackets will not be official until after weigh-ins are completed on Saturday.

### Saturday, January 16, 2010

7:00 AM Sign-in at computer and confirm roster.

8:00 AM Weigh-in at Cleveland State University Woodling Gym

A. All wrestlers shall be present and remain in the designated weigh-in area.

B. OHSAA Skin Authorization Forms properly dated must be presented at check-in.

C. The weigh-in shall proceed through weight classes beginning at 103 lbs. and end immediately upon completion of the 285 lbs. class. A contestant may step on and off the first scale two times. If he fails to make weight on the first scale, he shall immediately step on each available scale one time in an attempt to make weight.

9:45 AM Coaches Meeting

10:00 AM Championship Rat-Tails (2,3,3.5,4) \*If more than 32 wrestlers in weight class.

First Round (2,3,3.5,4)

Consolation Rat-Tails (1,2,2.5,3) \*If more than 32 wrestlers start after 45 minute rest.

Second Round (2,3,3.5,4)

First Consolation (1,2,2.5,3) \*If more than 24 wrestlers enter the bracket.

Mass (at conclusion of wrestling)

5:00 PM Second Consolation (1,2,2.5,3) \*No points for all byes in the 1st Consolations.

Quarterfinals (5,6,6.5,7)

Third Consolations (1,2,2.5,3)

\*Quarterfinals and Third Consolations wrestled at same time.

8:00 AM Weigh-in. Same procedure as Saturday. All wrestlers must be present at 8:00 AM!

10:00 AM Fourth Consolations (1,2,2.5,3)

Semifinals (11,12,12.5,13)

\*The semifinals will start at 10:30 AM on two mats while the consolations will continue on the others.

Consolation Quarterfinals (4,5,5.5,6)

Consolation semifinals (5,6,6.5,7)

3:00 PM Finals (4,5,5.5,6) & Fifth & Third (2,3,3.5,4)

**Seeding:** Seeding will be by criteria! Please read the seeding criteria carefully. **The online entry form must be submitted before 7:00 PM on Wednesday, January 13, 2010.** Please use the Online Form at [www.baumspage.com/cit](http://www.baumspage.com/cit)! Remember that you may change your roster at the meeting on Friday.

**Prior to the seed meeting:** If you are certain before Friday that a nominated wrestler is changing weight class, please notify Gary Baumgartner. If you know on Friday that you may be late to the seed meeting, please call Gary's cell phone at **513-594-6154** or Kevin Leigh at **440-845-2444 #128** or **cell: 440-212-0823** so the criteria can be applied to the proper weight class.

**After the seed meeting:** If a wrestler selected as a seed in one weight class moves to another class, he will be drawn randomly into the bracket for that weight class. The alternate will take his place in the original class.

## Seeding Information and Criteria:

- A. We will seed the top eight wrestlers in each class and select one alternate.
- B. Seeding will be based on the following criteria:
  - 1. State Champion
  - 2. State Place - in order of place.
  - 3. Catholic Invitational Champion.
  - 4. District Place - in order of place (\*Must be State Qualifier)
  - 5. Catholic Invitational Place - in order of place.
  - 6. Current overall record. (8 match minimum - must have winning percentage.)
- C. Seeds will be determined in order from first to eighth by applying the above criteria.
  - 1. If criteria #1 to #5 are equal, priority will be given to the wrestler returning in the same or lower weight class.
  - 2. Ties for winning percentage will be broken by head to head competition, then random draw between wrestlers involved.
  - 3. Wrestlers that qualify for seeds #1 to #6 must accept the seed. Those that qualify for #7, #8, or the alternate may "pass" on the seed!

## Re-draw Procedure on tournament day:

- A. Once brackets are drawn and printed, there will be no re-draws. However in order to maintain the integrity of the brackets as printed and to be fair to the contestants, the following procedure will be used:
  - 1. Seeded wrestlers will be rotated up to their appropriate line, and the replacement from their team placed on the line of the alternate.
  - 2. Non-seeded wrestlers lines on the bracket will become byes if a bye is legal.
  - 3. If a bye is not permitted, a coin flip (or series of flips) will determine which line will become a bye, and which wrestler must be moved to make the bracket legal.
  - 4. The over-all goal will be to maintain the integrity of the bracket in the simplest and fairest way possible.

## Procedure for Online Rosters and Seed Nominations:

- A. Use the **Online Roster and Seed Form** at [www.baumspage.com/cit](http://www.baumspage.com/cit) to submit rosters and seed nominations before **7:00 PM, Wednesday, January 13, 2010.**
- B. Please apply and set up your account **NOW**. You may finalize your roster later, but setting up and testing your account **NOW** will eliminate potential problems later.
- C. If you have problems check the **Help Page** first! For step-by-step instructions click the **Help** link on the **Login Page** and print the **Online Entry Instructions for Wrestling.**

- E. **Submit an "intended" roster early! Return anytime before deadline to make changes!**
  - 1. Use **Add/Modify Athletes** to enter your athlete's names and grades into the database.
  - 2. Use **Submit Event Rosters** to enter wrestlers into their weight classes.
  - 3. Click **Save/Submit and Print Rosters** to submit your tournament entry form.
  - 4. Click **Printable Roster and Confirmation Form** to print a copy for your records.
- F. Please note: **The online entry window will close precisely at the published deadline!**
- G. To nominate for a seed, fill-in the appropriate tournament information, and record.
  - 1. Indicate both the place and weight class that the wrestler competed in last year.
  - 2. District place must be State qualifier. (Top 4 at District.)
  - 3. Current record (Must be winning record with 8-match minimum!)

**H. There will be no additional seed nominations after Wednesday, January 13, 2010.**
