## ANNA JUNIOR HIGH HOME TRACK MEET INFORMATION

1. ENTRIES must be submitted using the online entry system at [www.baumspage.com](http://www.baumspage.com). Entries are due two nights before the meet is scheduled to be contested. Entry window closes at 9:00 PM. **Please enter a time and effort for every athlete**, even if you do not have one for them. This will allow us to make sure your best athletes will be in the fastest heats; otherwise they will be randomly placed in a heat. 2. No larger than 1/8" cone shaped spikes are allowed. Needle spikes are not allowed.
3. Starting blocks will be provided.
4. Chalk and cut tennis balls will be used for marking check points. No tape!
5. Parking for school buses will be beside the football field, off North Second Street. Spectators can park in the parking lots located around the high school south of the football / track complex. Please try to inform parents and others from your school who may be attending of the parking arrangements. They will not be able to park in the lots around the football / track complex.
6. There will be an admission fee of \$3.00 for adults and \$2.00 for students at all Anna High School and Junior High home meets.

Pole Vault: Order of competition: boys, girls.

I further certify that all student-athletes and other team personnel have been advised of their responsibilities relative to good sporting conduct during this competition. In addition, I understand and accept responsibility for adhering to the OHSAA participation limitation of four events per individual athlete per tournament contest.
