**Tie-Breaker Criterion**

- The winner shall be the wrestler who:
1. Won the greater number of matches.
  2. Won the head-to-head match.
  3. Has been penalized the least number of team points for flagrant or unsportsmanlike conduct.
  4. Accumulated the greater number of team points for all matches.
  5. Accumulated the greater number of team points for all for falls, defaults, forfeits, or disqualifications.
  6. Accumulated the greater number of team points for technical falls.
  7. Accumulated the greater number of team points for major decisions.
  8. Accumulated the greater number of team points for decisions.
  9. Accumulated the greater number of pins in the least time.
  10. Accumulated the quickest pin.
  11. Accumulated the greatest total point differential for decisions.
  12. If none of the above resolves the tie, a flip of a coin will be used.
