Final brackets will be available at the coaches meetings after weigh-ins. The schedule for the weekend is below. Medals will be awarded at the end of each tournament.

Barring unforeseen difficulties, seed nominations will be posted before noon! **No additional seed nominations accepted after February 19th!** \*See instructions on next page.

## **Seed Meeting: THERE WILL BE NO SEED MEETING THIS YEAR!**

- A. We will seed the top four wrestlers in each class
- B. Seeds will be determined in order from first to fourth based on their record
- C. At this point in the season, records against other seed nominees **head to head should be given priority!** These situations will be discussed at the coaches meeting after weigh-ins
- D. Brackets will not be official until after weigh-ins

## Friday, February 20, 2015

3:30 Sign-in at computer to confirm entries. School dismisses at 3:05. You will not be able to get into the parking lot until after 3:20

- A. \*Must present copy of the **Weight Certification Alpha Master Report!**

3:30 Scales open for weight check

4:00 – 4:30 **Weigh-in:**

- A. All OHSAA Skin Authorizations appropriately signed & dated must be presented at check-in.
- B. Weigh-in by team.

4:30 Coaches meeting to go over brackets

5:15 First Round (2,3,3.5,4)

Quarterfinals (2,3,3.5,4)

First Consolation (1,2,2.5,3)

Semifinals (12,13,13.5,14) & Second Consolation (1,2,2.5,3)

\* Second Consolations and Semifinals wrestled simultaneously.

Consolation Semifinals (5,6,6.5,7)

Finals \*Approximately 30 to 45 minutes after consolation semifinals.

First Place (4,5,5.5,6) & Third Place (3,4,4.5,5)

- A. All awards will be presented after the 245/285 finals.

- B. **Note: There will not be a 3rd Place match if either wrestler has already wrestled 5 times. The wrestler who has not wrestled 5 times will place 3rd by forfeit! If both wrestlers have wrestled 5 times, there will be no match and no points will be awarded!**

### Seeding Criteria

1. State Place – in order of place (1 thru 8)
2. District Place – in order of place (1 thru 4)
3. Head to Head competition (these situations will be discussed at coaches meeting after weigh-ins)
4. Current Record

If records warrant, up to four seeds will be selected. Wrestlers will be listed on the Seed Nomination Form. **Final seeding will be done during the coaches meeting after weigh-ins on Saturday.**

### **To enter roster and seeds online:**

- If you are not a “computer user” find an assistant, parent, friend or athlete to help you out!
- Go to [www.baumspage.com](http://www.baumspage.com) and follow the links to the **GCL Tournament** and the **Online Roster and Seed Form**. Make sure you select the correct level – **Varsity/JV/Freshman!**
  - If you don’t already have an account, click on **Apply**, enter your information, select your **School** and **Sport** from the drop down menus, and then click on **Submit Application**.
  - If you already have an account, click on **Login** and enter your **UserID** and **Password**.
    - The **UserID** is the e-mail address you submitted and the **Password** is what you chose!
  - If you forget either your **Password** click the **Forgot my Password** link.
    - **UserIDs** are listed by school and **Passwords** are e-mailed to the user’s email address.
- Please apply and set up your account **NOW**. You may finalize your roster later, but setting up and testing your account **NOW** will eliminate potential problems later.
  - If you have problems check the **Help Page** first! For step-by-step instructions click the **Help** link on the **Login Page** and print the **Online Entry Instructions for Wrestling**.

- **Submit an “intended” roster early! Return any time before deadline to make changes!**
  1. Use **Coaches | Modify Athletes** to enter your athlete’s names and grades into the database.
  2. Use **Coaches | Submit Rosters** to enter wrestlers into their weight classes.
    - Select **GCL Tournament** and the correct level.
    - Click on the weight and select the wrestler.
    - Enter records only for the wrestlers that you are nominating for seeds.
  3. Click **Submit Rosters** to submit your tournament entry form.
  4. Click **Get Printable Roster** to print a copy for your records.
- **The entry window will close precisely at 11:00 AM on Thursday, February 19<sup>th</sup>!**
  - You may login and make changes any time prior to the entry deadline!
  - Click **Submit Roster** to submit the changes.
- Barring unforeseen difficulties, seed nominations will be posted on the web before 12:00 Noon on Thursday! Hit update or refresh to view the most current data!
- Final seeding will be done at the coaches meeting on Saturday.
