

10th Annual Lakota East J. V. Wrestling Tournament

Saturday, December 3, 2011

Teams: Centerville, Colerain, Elder, Fairfield, Hamilton, Harrison, Kettering Fairmont, LaSalle, Mason, Middletown, Milford, Moeller, Oak Hills, Princeton, Hilliard Davidson, St. Xavier, and Ryle. (17)

Entry Fee: \$150.00 (Payable to Lakota East Athletic Department)

Admission: \$5.00 for Adults - \$3.00 for Students

Passes: Passes will be limited to the number of participants plus four for support personnel. Passes may be used by your statisticians, trainers, or other designated personnel.

Lockers: Please have your wrestlers lock their valuables and personal items. Please help out by monitoring your team in the locker room.

Awards: Team trophies for 1st and 2nd place teams. Medals awarded for the top 3 placewinners and anybody who has had to withdraw due to the 5 match limit, but won their last match.

Concessions: The Lakota East Athletic Boosters will provide a concession stand with a variety of items.

Rosters: Use the **Online Roster Form** at www.baumspage.com/wr/lejv. Entry window opens **Nov. 28 @ 8:00 AM** and closes @ **12:00 noon on Friday, Dec. 2, 2011**. **Please adhere strictly to this deadline or your team will face the possibility of being eliminated from the tournament.**

- You will need to create an account first.
- For step-by-step instructions click the **Help** link on the login page and print instructions for Wrestling.
 - a) Use **Add/Modify Athletes** to enter your athlete's names and grades into the database.
 - b) Use **Submit Event Rosters** to enter wrestlers into their weight classes.
 - c) Click **Save and Submit Rosters** to submit your tournament entry form.
 - d) Click **Printable Roster and Confirmation Form** to print a copy for your records.
- **Please submit an "intended" roster early! Return anytime prior to deadline to make changes!**

- You may make changes to your line-up when you check-in Saturday morning!

Special Note for the 2011 Tournament: Because of the fact that most teams are coming with full line-ups plus extras; we switched from using a 16-man bracket to a 32-man bracket in 2010. This eliminated the problems that we ran into in 2009. However, what this means is that a wrestler will be done (regardless of where they are in the bracket) once they meet the 5-match maximum. We decided to choose this approach rather than eliminate teams from the tournament.

Please note:

- A. There will be no seeding for this tournament. We will use the seeding procedure to separate wrestlers from the same team as much as possible.
- B. Wrestling will start with the First Round as soon as the brackets are distributed. There will only be short breaks if needed to insure the 45 minutes between matches.

10:00 First Round (2,3,3.5,4)

Second Round (2,3,3.5,4) & First Consolation (1,2,2.5,3) *If more than 24 wrestlers.*Simultaneously

Second Consolation (1,2,2.5,3) *If more than 16 wrestlers.

Quarterfinals (2,3,3.5,4) & Third Consolations (1,2,2.5,3) *Simultaneously

Fourth Consolations (1,2,2.5,3)

Semifinals (12,13,13.5,14) & Consolation Quarterfinals (1,2,2.5,3) *Simultaneously

Consolation Semifinals (5,6,6.5,7)

Finals (4,5,5.5,6) & Third (3,4,4.5,5) *All awards presented after the 285 Final.

Note: There will not be a match if either wrestler has already wrestled 5 times. The wrestler who has not wrestled 5 times will win by forfeit! If both wrestlers have wrestled 5 times, there will be no match and no points will be awarded!
