- The Online Roster Entry Window will open at 8:00 AM, Sunday, September 19 and close at 5:00 PM on Monday, October 18.
 - Before you can access the Submit Seed Bio and Vote form, you will need to submit a "tentative" roster listing up to 7 athletes that you intend to enter.
 - You can make changes to the submitted roster until October 18th at 5:00 PM.

 - The teams will be listed in random order. Drag and drop them in ranked order from 1st to last. Click Save Vote.
 - Coaches may vote for their own team! Prior to final tabulation the highest and lowest votes for each school will be dropped.
 - If a coach does not submit the seeding ballot, the highest seed ranking submitted by the other coaches will be deducted from their team's total calculated score and the school may be subject to a \$50 fine.
- The final tally listing teams in ranked order will be posted on Sunday, October 10 by 4:00 PM!
- Full teams (5 or more runners) will be seeded first. Schools without full teams (4 or fewer runners) will be assigned to the district races by the manager.
 - The teams will be assigned to their race by rank.
 - #1 will be assigned to Race 1, #2 & #3 to Race 2, #4 & #5 will be assigned to Race 1, #6 to Race 2, #7 & #8 to Race 1, #9 & #10 to Race 2, #11 & #12 to Race 1, #13 & #14 to Race 2, #15 & #16 to Race 1, #17 & #18 to Race 2, #19 & #20 & #21 to Race 1 and #22 to Race 2, until all teams are assigned..
 - Race 1 and Race 2 races will both qualify to Tiffin.
