Welcome to the 2021 District Wrestling Tournament at Perrysburg High School.

It is the goal of the tournament staff to make the District Wrestling Tournament a smooth and successful experience for the wrestlers, coaches and fans. Per OHSAA guidelines and the Wood County Health Dept. Protocols, this year the district tournament will be **run in split sessions**. The OHSAA has notified schools that alternates **WILL NOT be admitted** if they are not used. Unfortunately, due to capacity limits and COVID-19 protocols, school or team yearbook, newspaper, or photographers **WILL NOT be admitted**. Each team will be given coaching passes based on the OHSAA rubric for the number of participants entered. Furthermore, due to COVID-19 protocols, there will unfortunately **NOT be a hospitality room** for coaches like in years past.

For teams arriving at Perrysburg High School, please take note that school will be in session. The district tournament will have two sessions. Teams are encouraged to have **only their first group** of wrestlers arrive before 10:45 a.m. All **team** arrivals must enter the school from **Fort Meigs Road** and will be directed to the designated parking area for school transportation. For fans and spectators, doors will open at 11:30 a.m. Review the schedule for the times for the second session.

This Northwest District wrestling tournament is under the supervision and sponsorship of the Ohio High School Athletic Association, the Northwest District Athletic Board, and Perrysburg Exempted Village Schools.

Thank you in advance for your cooperation during this challenging time and ensuring your team and fans follow the COVID-19 protocols set by the Wood county Health Department. This includes wearing a mask, social distancing, remaining in the designated areas, and temperature checks. We wish you and your program the best of luck.

## **B. Tournament Schedule**

**10:30 a.m. SESSION 1 Check-in**

- \*Please check in at the head table upon arrival in the commons area.
- \*Review records listed and make corrections as needed.
- \*Please **check** all names, spelling, and records listed on the sign-in sheet. Data will update automatically all the way through to the State Tournament for those wrestlers that qualify.

**11:00 a.m. | SESSION 1 Weigh-in (106-145 on 4 mats)** (end after the 145 lbs. class finishes.)

- \*Officials will check contestants for grooming and skin condition before weighing in for the tournament. Any physician's notes/releases must be available for officials to weigh in.
- \*4 scales will be used for weighing in contestants. Scales will be open to check weights from 10:30 a.m. to 10:55 a.m.
- \*All wrestlers shall be present and remain in the designated weigh-in area.
- \*Weigh-in by weight class. The weigh-in shall proceed through weight classes beginning at 106 lbs. and end immediately upon completion of the 145 lbs. class. A contestant may step on and off the first scale two times. If they fail to make weight on the first scale, they shall immediately step on each available scale one time in an attempt to make weight.

## **E. Rules/Regulations**

The National Federation Wrestling Rules, as may be modified by the OHSAA Board of Directors, shall be used in all wrestling tournaments sponsored by the OHSAA.

All OHSAA bylaws and sports regulations apply to the conduct of the OHSAA wrestling tournaments including the prohibition that a student who uses anabolic steroids or other performance enhancing drugs is ineligible for interscholastic competition until such time as medical evidence can be presented that the student's system is free of anabolic steroids or other performance enhancing drugs.

### **Unsportsmanlike Conduct Policy**

During participation in OHSAA tournaments, any student or coach ejected for unsportsmanlike conduct or a personal foul, shall be ineligible for the remainder of that tournament as well as for all contests in wrestling until two regular season/ tournament contest (points) are competed at the same levels as the ejection. Individuals ejected for unsporting conduct shall be reported to the OHSAA commissioner's office by the tournament manager. The Commissioner's Office may impose additional penalties in accordance with Bylaw 11.

## **F. District Tournament Alternates**

The OHSAA has notified schools that alternates **WILL NOT BE admitted** if they are not used. The use of an alternate from sectional to district or district to state is permissible when a qualifying wrestler cannot compete due to illness, injury, failure to make weight, flagrant misconduct or academic ineligibility. The alternate may be placed on the bracket up until the

time that weigh-ins end. The alternate shall be the next highest finisher from the previous tournament. The alternate shall be placed on the vacated line of the bracket. No other wrestler will be moved on the bracket. **(No expenses will be paid nor free admission passes granted to alternates unless they actually participate.)**

### **G. Passes/Admission**

There will be no complimentary tickets given to participating schools for administrators. All spectator seating will be designated for wrestler's loved ones. The NWDAB will be using home town ticketing to allow the families of participants to purchase a maximum of two tickets.

Packets will include assigned number of participants and passes (to be used for coaches, school officials, mat maids) **With the using split sessions, this would mean that a school would be permitted no more than 4 coaches per session.**

**There will be no other allotments for team / school personnel (videographers, statisticians, etc.)**

- 1 qualifiers - 2 coaches
- 2-4 qualifiers - 3 coaches
- 5-9 qualifiers - 4 coaches
- 10-14 qualifiers - 5 coaches

The person that uses a pass is up to the head coach of each school qualifying. Any additional personnel will need to purchase an online ticket for admission.

Wristbands will be used for all non-wrestlers. Wristbands must be issued at the pass gate entrance on the first day of competition.

General Admission – **Adults - \$10.00 per session – Students - \$10.00 per session**

**The gym will be cleared between Session 1 and 2 and Session 3 and 4. All session Adults \$20 and students \$20.**

### **H. Media and Photographers**

All requests for media credentials at sectional/district tournaments shall be directed to the tournament manager. Proper credentials must be presented for admission at the pass gate. Schools interested in **obtaining a media credential must notify the tournament director by March 4, 2020. Email: mr.rmugrove@gmail.com**

### **I. Tournament Procedure**

4 mats will be used Friday

Only wrestlers in uniform and coaches with participation passes will be allowed on the gym floor/mat side.

**Only 2 coaches / team personnel will be permitted mat side** – this will be strictly enforced.

Violators may be removed from the gym for the remainder of the session.

Wrestlers will be called on-deck to a specific mat and should be ready to wrestle. (warm ups off and headgear on) as soon as the match before theirs on the assigned mat is completed.

### **J. Scoring/Awards**

\*Awards for each weight class will be presented mat side at the conclusion of each weight class.

\*6 places will be scored – the top 4 place winners in each weight qualify for the \*OHSAA State Tournament

\*Individual medals will be presented to the top 6 place winners in each weight

\*Team awards will be presented to the District Champion team and Runner-Up

### **K. Videotaping**

**All videotaping and photography must be done from the spectator area and shall not interfere with the view of other spectators!**

Videotaping or filming by participating schools:

\*Videotaping or filming of tournament contests by one or more schools participating in the contest is permitted provided prior arrangements are made with the tournament manager and it is done at the expense of the school involved. **From the stands**, a maximum of one individual per school is permitted.

Videotaping or filming by spectators:

1. Videotaping will only be done from upstairs and shall be for personal use.
2. Shall not be used for the purpose of scouting or coaching.
3. Shall not interfere with the view of the athletic contest by other spectators.
4. The tournament site shall not permit the use of more than the seating space for which the spectator has paid when seating is needed for paid fans.
5. The tournament site accepts no liability for damage or theft of spectator equipment or injury as a result of privately owned equipment.
6. Equipment will not be permitted in any competition area – only in the spectator seating area.
7. The tournament site will not provide sources of power for video equipment.
8. Violation of this regulation may result in the removal of offenders from the premises.

### **M. Inclement Weather**

In the event that weather becomes an issue, Perrysburg Exempted Village Schools and the Northwest District Board will make the determination if the event will be delayed or canceled. Media will be contacted. If there is any question regarding the event related to weather issues, it is your responsibility to call, if there is any possibility that it might be delayed or canceled.

#### **N. Professionalism of Coaches:**

It is the moral obligation of all Ohio Wrestling Coaches to conduct themselves in a manner that reflects credit upon their high school, their profession and themselves. Personal grooming and appropriate dress is a standard of professionalism. **The wearing of jeans, t-shirts, sweat suits and warm-up suits (top or bottom), head wear and similar apparel are not considered suitable attire for coaches during the OHSAA Sectional, District or State Wrestling Tournaments and, therefore, are prohibited. Coaches who are inappropriately dressed will not be allowed on the competition floor.** Moral behavior and ethical conduct are part of winning and losing. Good sportsmanship, appearance, honor, and concern for the well-being of the competitors must be every coach's priority. The rules have been established in the spirit of this statement.
