18 Holes of Play

1. All competitors will play from the gold tees.
2. All balls must be holed.
3. The stroke and distance penalty applies to out of bounds and lost balls.
4. USGA and OHSAA rules apply.
5. Scoring will follow OHSAA guidelines.
6. Record scores correctly after completing each hole.
7. All players must report to the scoring area immediately following completion of the round.
8. Two signatures are required on each scorecard after 18 holes.
9. Only one school board approved coach/designee is permitted to speak with players without delay of play during the round.

Official Scorecard – 1 name and 1 score only.

Out of bounds: Defined by white stakes and/or painted lines. Located left on holes #8, #9, #11, #12, and #16. Right on #18. Behind the green on #7, #9, #11, and #12.

Penalty Areas: Defined by RED and/or YELLOW stakes and painted lines. The type of area the ball is in will affect relief options. Rule 17.

Players may take relief, not nearer the hole, from all white circled and yellow flagged areas. These areas are considered ground under repair.

Rule infractions should be immediately addressed with a rules official and penalty strokes assigned if necessary. Players should not wait until the end of the round to settle rule disputes.

All ties for qualifying positions will be settled via playoff beginning on hole #10 immediately after the round.

Spectators

- Spectators are permitted on the golf course but must remain ½ hole ahead or behind players. Coaching or advising is prohibited. Conversation with a player may result in that player's disqualification.
- Cell phones are prohibited.
- Spectators may help search for lost balls.

Qualifiers to the District Tournament to be played at Ellsworth Meadows in Hudson, Ohio on Tuesday, October 8 will be the FOUR lowest scoring teams and the FOUR lowest scoring individuals not on a qualifying team.
