Click the link to **Online Entry Link**. The window for entries **opens at 2:00 pm on Sunday, January 26** and **must be submitted by 7:00 pm, Wednesday, February, 12, 2014**.

Seeding Criteria: 1. State Place 2. District Place 3. Sectional Place 4. Current Record

Four seeds and 1 alternate will be selected. Wrestlers will be listed on the Seed Nomination Form based on the above criteria. However, at this point in the season, head to head results should be given a priority! Please read the seeding criteria and drawing procedures (on back) carefully.

1. **Entries must be submitted using the Online Entry Form at www.baumspage.com**
 - a) Create your account early and enter your master alphabetic roster.
2. **Please note the following changes on baumspage.com**
 - a) All User Accounts from last year are still active.
 - b) After login, the coach will be able to add multiple teams/sports/genders to the same account!
3. Go to www.baumspage.com and click **Online Entries** or **Login** to access your account.
 - a) If you did not have an account last year, use **Apply** to create your account.
 - b) If you had an account last year, you can login using that e-mail address and password.
 - i) **Please note: Passwords are case-sensitive!**
 - ii) If you don't know your password, click the **Forget your password?** link to have a temporary password e-mailed to you.
4. Use **• Coaches | Select Teams** to select your school from the drop-down list.
 - a) Click **Get Available School Teams** | click **Select Sport** in the dropdown below | highlight your sport | then click **Make me the Coach**.
 - b) If your school is not listed or somebody else has already claimed your team, use **My Tools | Online Help** and submit the appropriate **Help Request**.
5. Use **• Coaches | Wrestling | Modify Athletes** to enter athletes to your alphabetic roster.
 - a) You may enter athletes one at a time by entering first name, last name, and grade, then **Add Athlete**.
 - i) Type all names in upper and lower case. ***Please check all entries carefully!**
 - b) Or you can import your complete roster by pasting them from an Excel file. Use one row per athlete: **First Name, Last Name, and Grade**. Highlight and paste into textbox, then click **Import Athletes**.
6. Use **• Coaches | Wrestling | Submit Rosters** to enter them in a tournament.
 - a) Select your team | click **Get Available Events** | Select an event | click **Get Roster**.
 - i) For each weight class, click **Select a Wrestler** and select the athlete from the drop-down list.
 - ii) Enter seeding information as requested. **Enter records for all wrestlers!** All wrestlers will be listed on the seed nomination sheets, regardless of record.
 - b) Click **Submit Roster** to save. Use **Get Printable Roster** to print a copy for your records.
 - c) If a name or grade is not correct or an athlete is missing, use **• Coaches | Wrestling | Modify Athletes** to make the correction, then submit your entries again.
7. **Event Rosters can only be submitted or corrected while the "Entry Window" is open!**
 - a) The window closes automatically **precisely at the time and date listed. (February 12 at 7:00pm)**
 - b) **Submit Rosters** early and return to make changes **anytime before** the window closes.
 - c) **Entries cannot be edited or submitted online after the window closes.**
8. **If there are any problems with the Online Form**, click the **Contact Us** link and submit a **Help Request**.
 - a) **Please allow up to 8 hours for a response! *Most responses will be in less than 4 hours.** Call Gary Baumgartner at 513.594. 6154 or Terry Young at 740.517.0195 if you need immediate help.

Tippecanoe Division II - Tippecanoe 2 - Entry Procedure and Deadlines

Wednesday, February 12, 2014: Item #1

1. Online Roster (**Submit by 7:00 pm on Wednesday, February 12th**)
 - Data submitted online will be accepted in lieu of the Official OHSAA Entry Form.
 - **Include grade and record for all wrestlers. All wrestlers will be on the seed nomination list.**
 - Print the Confirmation Form! Correct records on the form and bring to the meeting (if needed).

Thursday, February 13, 2014, Items #2 and 3 are due at the Seeding Meeting 7:00 pm at Tippecanoe High School

2. OHSAA Eligibility Certificate (1 per Qualifying School) to be handed in
3. OHSAA Wrestling Weight Certification Alpha Master Sheet and Alpha Master Weigh In Sheet

Seeding Procedure -- Please read the following information carefully:

For the Sectional Tournament, the competing wrestlers must:

1. Be listed on the eligibility certificate and Weight Certification Alpha Master Report.
2. Wrestle only at the Alpha Master Weight class or weight class above as specified by the rules.

After the seeding and draw for a weight class is completed, a wrestler

1. Cannot be entered in another weight class.
2. Cannot be substituted for if he fails to make weight.
3. May be substituted for, prior to weigh-ins, in the event of injury or illness.

Seeding Information and Criteria:

- A. We will seed the top four wrestlers in each class and select one alternate. Once a wrestler is nominated for seeding, they cannot be withdrawn from the seed by the coach (Board Action.)
- B. Seeding will be based on the following criteria:
 1. State Place - in order of place.
 2. District Place - in order of place.
 3. Sectional Place - in order of place.
 4. Head to head competition against other seed nominees.
 5. Record against common opponents.
 6. Current overall record (Top winning percentage.).
- C. Seeds will be determined in order from first to fourth by applying the above criteria.
 1. If criteria #1 to #3 are equal, priority will be given to the wrestler returning in the same or heavier weight class.
 2. Ties for winning percentage will be broken by head to head competition, then random draw between wrestlers involved.

Re-draw Procedure on tournament day:

- A. Once brackets are drawn and printed, there will be no re-draws. However in order to maintain the integrity of the brackets as printed and to be fair to the contestants, the following procedure will be used:
 1. Seeded wrestlers will be rotated up to their appropriate line, and the replacement from their team placed on the line of the alternate.
 2. Non-seeded wrestler's lines on the bracket will become byes if a bye is legal.
 3. If a bye is not permitted, a coin flip (or series of flips) will determine which line will become a bye, and which wrestler must be moved to make the bracket legal.
- B. The over-all goal will be to maintain the integrity of the bracket in the simplest and fairest way possible.
