Welcome to Clinton Massie High School. We pleased to be hosting the sectional tournament and we ask for your cooperation in making this a great experience for all involved.

**Team Entrance & Locker Rooms**

**Team Entrance/Pass Gate:** Enter at the door nearest the Tennis Court. Park busses in the lot between the Tennis Court and the Elementary Building. Do not park in any slot marked with a blue slash.

Locker Rooms: Will be available, however we do not recommend that your wrestlers leave personal belongings in there as the facilities will be shared. Schools will be listed on the locker room doors. NOTE: Any damage to the facility will be billed to the offending school. Teams will be assigned to locker rooms. Some are in the hallway near the HS gym, and some are in the Middle School gym.

**Athletic Trainer**

An athletic trainer will be available on site.

**Concessions**

Concessions will be provided. We ask that all be courteous and remove any trash. No crock pots or large coolers will be allowed.

**Check-ins and Weigh-ins**

\*Teams may arrive **between 2:45 and 3:30 on Friday** for check in at the head table.

\*All participants must be **in the gym by 3:30** to conduct weigh-ins and skin checks by weight class. Weigh-ins will be in room 333.

\*There will be a mandatory seed meeting held during weigh ins in Classroom 331, across from the weight room \*Weigh-outs **will begin after the 145 pound weight class** in the quarter final round.

\*Skin checks will be performed **during weigh-ins, and wrestlers must have any proper paperwork** with them when they enter. All decisions on skin issues will be decided by the medical personnel on site.

\*Saturday check in from 9:00-9:30

**Start Times**

Friday: 5:00 PM

Saturday: 10:30 (weigh-ins as needed and skin checks at 9:00 AM) Finals will start 30 minutes after complete of C. Semis.

**Admission**

All tickets at the gate are **\$6.00 for the prelims, and \$7 for the finals. The gym will be cleared between session 2 and 3 on Saturday. Policy** as set by the Southwest District Athletic Board.

On Friday, all session passes will be available for \$15.

### **Passes and Pass List**

The only passes accepted are SWDAB passes. Those on your **TEAM PASS LIST** will be granted free admittance. A reminder that trainers, scorers, bus drivers, video personnel, etc...MUST have a ticket if they are not included on the team pass list.

Admission guidelines:

- \*All wrestlers who make weight and are eligible to wrestle
- \*Each school will be allowed additional people based on number of competitors
  - 1-6 Competitors – 4 Additional Passes
  - 7-10 Competitors – 5 Additional Passes
  - 11-14 Competitors – 6 Additional Passes
- \*These passes are for Coaches, Stats, Managers, and Support Personnel. Not spectators.

### **Officials**

Officials have been assigned by the Ohio High School Athletic Association.

### **Crowd Control**

#### **\*Videotaping or filming by participating schools:**

- Filming or videotaping of tournament matches is permitted provided the permission of the tournament manager is secured and it is done at the expense of the school(s) involved. This may NOT BE done matside unless using one of the two chairs allowed for coaches. The Crow's Nests are available for filming.

#### **\*Videotaping by spectators:**

- Any and all videotaping by spectators shall be for personal use.
- Videotaping shall not be for the purpose of scouting or coaching.
- Any and all videotaping shall not interfere with the view of the athletic contest by other spectators.
- The tournament site shall not permit the use of more than the seating space for which the spectator has paid when seating is needed for paying fans. Spectators may film from the available crow's nests or from their seats. No matside videotaping unless in one of the two coaches' chairs.
- The tournament site accepts no liability for damage or theft of spectator equipment or injury as a result of privately owned equipment.
- Equipment shall not be permitted in any mat area--only in the spectator seating area or crow's nest.
- The tournament site shall not provide power sources for video equipment.
- Violation of this regulation may result in the removal of the offender from the premises.

**\*Spectators are NOT ALLOWED on the floor of the gym or matside. They must be in the bleachers. Only two OHSAA certified coaches per mat in the chairs provided or one coach and one statistician or videographer. The videographer may not serve as a coach when seated in coaches' chairs.**

### **Signs, banners & noisemakers:**

Signs and noisemakers will not be permitted, except for small, hand-held signs. They may not take up a seating space.
