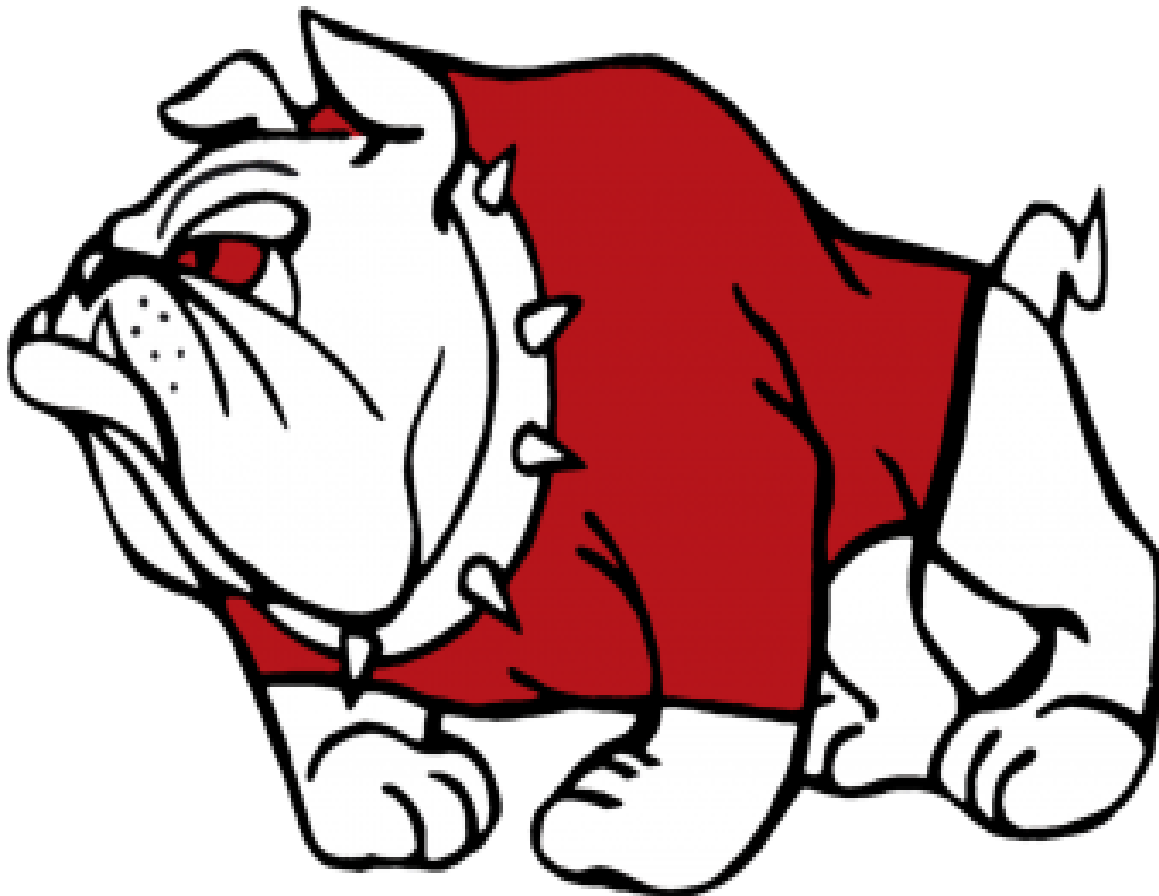


**2021 - 2022 Canton McKinley Invitational**

## *Canton McKinley Invitational*

**When:** Wednesday December 29<sup>th</sup> 2021, Thursday December 30<sup>th</sup> 2021

**Weigh-ins:** Weigh-ins will begin promptly by team upon the order of arrival, at 8:00 a.m. and end when each wrestler has made his attempts. We are waiting to hear back from The OHSAA for permission to weigh out Thursday night at the conclusion of wrestling.

**Information:** We will be using 6 mats and 8 officials. We will be using [Baums Page](#) for roster submission, seeding criteria, Pool Matches Day 1, and Bracket Matches Day 2.

**Entry Fee:** \$ 250.00 per team  
(Please remember to mail the check or bring with you on the day of the tournament)

**Awards:** Awards will be given for 1<sup>st</sup>, 2<sup>nd</sup>, and 3<sup>rd</sup> place teams. Individual awards will be given for wrestlers placing 1<sup>st</sup> – 4<sup>th</sup>.

**Seeding:** ***A preliminary Roster must be entered to Coach Blackiston by Friday 12-18-19.*** The reason for this is most schools go on Christmas break. You can call Jason Blackiston (Tournament Director) @ 330-265-3513 if you have any questions or additional extra wrestlers. **There will be no seeding meeting!** Extra wrestlers will be placed in pools/brackets as spots are available. These wrestlers will not be seeded.

**Criteria :**

1. State Placement 1-8
2. District Placement 1-6
3. Sectional Placement 1-4
4. Varsity record (> .500) , if 5 or more matches, use this year's record, if less than 10, please use last year's record
5. Non-Seeded and extra wrestlers will be randomly placed into pools, though as best as possible, we will try to avoid pairing extras with their teammate.

**Concession/Hospitality:** Will be open all day both days

**Admission Fee:** Admission for students/children/seniors will be \$4.00 and adults \$7.00.

### Bus Information:

Please make sure you enter this information as it will help create evenly distributed pools.

### Seeding criteria will be:

State placement (1 - 8)

District placement (1 - 6)

Sectional placement (1 - 4)

Varsity Win percentage > 50% ( ← **Please use last year's record unless they have 5 or more matches this year**)

*\*\*If you believe a freshman qualifies to be seeded, please email me their JH accomplishments\*\**

## **Extra Wrestlers:**

Please enter as many extra wrestlers as you wish onto your roster.

We will accommodate as many extras as we can, based on the number of varsity entrants for each weight class entered.

Extra Wrestlers can earn individual placement, but will not score team points.

**Please note that we can not guarantee all extras will get in.**

**Tournament Format:**

- Two day tournament
- Round robin pools to bracket format
- Day 1 = 5 rounds
- Day 2 = 6 rounds

**\*\*Based on 8 man field\*\***

- Day 1 = Two 4 man pools, wrestle first 3 round robin matches, Then AvB Semi/Final Bracket
- Day 2 = Wrestlers will be placed into a Double Elimination 8-man gold bracket

**\*\*Based on 12 man field\*\***

- Day 1 = Two 6 man pools, wrestle round robin matches
- Day 2 = Wrestlers will be placed into a Double Elimination bracket

**\*\*Based on 16 man field\*\***

- Day 1 = Four 4 man pools, wrestle first 3 round robin matches, Then AvB Semi/Final Bracket, And CvD Semi/Final Bracket.
- Day 2 = Wrestlers will be placed into a Double Elimination bracket
- Gold Bracket will be top 2 from each pool, Silver Bracket will be bottom 2 from each pool

**\*\*Based on 20 man field\*\***

- Day 1 = Four 5-Man Pools, wrestle round robin matches
- Day 2 = 12-man Gold bracket, 8-man silver bracket
- Gold Bracket will be top 3 from each pool, Silver Bracket will be bottom 2 from each pool

**\*\*Based on 24 man field\*\***

- Day 1 = Four 6-Man Pools, wrestle round robin matches
- Day 2 = 12-man Gold/silver bracket
- Gold Bracket will be top 3 from each pool, Silver Bracket will be bottom 3 from each pool

**Scoring:**

**\*\*Pool round robin rounds\* (Day 1)**

- Modified dual meet scoring will be used for pool play
- Rounds 1-5
- Pin= 2
- Tech= 1.5
- Major= 1
- Decision= .5
- Pool placement is only used for seeding in the Day 2 bracket.
  - **There will be NO placement points awarded for pool matches**

**\*\*Bracket Rounds\* (Day2)**

- Modified dual meet scoring will be used for the bracket rounds
- Pin= 4 (2+2 advancement pts)
- Tech= 3.5 (1.5+2 advancement pts)
- Major= 3 (1+2 advancement pts)
- Decision= 2 (.5+2 advancement pts)
- Wrestlers who have a "BYE" in the first round of the bracket will receive an additional 2 advancement points for that round if they win their next match
- **Wrestlers in the Silver bracket will not earn team points for the tournament once the bracket session has started.**

**\*\*Placement Points\***

- Placement Points will be awarded for top 8
- Modified dual meet scoring will be used for the Finals (pin=2, tech=1.5, maj=1, dec=.5)
- 1st - 14+ Modified Dual meet scoring
- 2nd - 12
- 3rd - 9+ Modified Dual meet scoring
- 4th - 8
- 5th - 5+ Modified Dual meet scoring
- 6th - 4
- 7th - 2+Modified Dual Meet scoring
- 8th - 1

**Awards:**

- Individual Awards for 1st - 4th place
- Team Awards for 1st - 3rd place
- Most Outstanding Wrestler (106 - 145 lbs)
- Most Outstanding Wrestler (152 - 285 lbs)

**Economic:**

- Admission fee each day is \$7 for adults, \$4 for children
- Concession Stand is available all day for spectators
- Hospitality Room will be available for coaches and officials only

## **TOURNAMENT FORMAT**

The format has changed due to the increase of teams. Out of the 15 teams, in each weight class we will seed all possible seeded wrestlers. We will use as many wrestlers as are entered into [baums page](#) up to 24 per weight class so that every wrestler gets the opportunity to get as many matches as possible. In weight classes that allow it, we will split into 2 pools, (106/107 baumspage does not allow for 106A and 106B) and use the placement from the pools for the bracket on Day 2. Day one will be a pool format and day two will be a bracket style format.

DAY 1 = POOLS (6 Rounds)

**We will split weight classes to maximize the amount of matches for Day 1**

DAY 2 (6 Rounds)

The top 4 wrestlers from each bracket will go into the **GOLD** bracket, and the bottom 4 wrestlers will go into the **SILVER** bracket. The brackets will be an 8-Man Bracket format. Only the wrestlers in the **GOLD** bracket will earn placement points. Coaches meeting will be used to place wrestlers into the proper finals matches in result in a tie in a bracket. We will use a maximum 12-person bracket format to adhere to the 5 match rule

# Canton McKinley Invitational Scoring

## Pool Scoring

All wins will be scored as a Tournament scoring. Ex. Pin = 2 pts, Tech Fall = 1.5 pts, Major Dec.= 1 pts, Decision = 0.5pts. If a team has an open weight class that will be counted as a forfeit for scoring purposes. The result of the match will only be reviewed in the result of a tie.

## Pool Tie Breaker

1. Head to Head → *Will determine placement in a 2-way tie*

*\*\*The following criteria will only be needed in the event of a 3-way tie where all three went 1 - 1 against each other\*\**

2. Most Pins
3. Most Technical Falls
4. Most Major Decisions
5. Most Points Scored (Tournament scoring)
6. Most individual points in matches scored
7. Fastest pin time
8. Coin flip

## Placing Scoring

### Placement Points

- 1<sup>st</sup> = 14 + Modified Dual Meet Scoring  
2<sup>nd</sup> = 12  
3<sup>rd</sup> = 9 + Modified Dual Meet Scoring  
4<sup>th</sup> = 8  
5<sup>th</sup> = 5 + Modified Dual Meet Scoring  
6<sup>th</sup> = 4  
7<sup>th</sup> = 2 + Modified Dual Meet Scoring  
8<sup>th</sup> = 1
